

How Mechanical Systems Help Virus Mitigation

ASHRAE's suggestions are as follows:

- » Ensure facilities meet all current standards for ventilation and thermal conditions

- » Consider adding supplemental filtration, ultraviolet germicidal irradiation (UVGI) solutions, or other air cleaning technologies
- » Remember, higher efficiency filters can be low-cost and quick to implement
